SUBJECT: MEETING WITH NUCLEAR ENERGY INSTITUTE AND MEMBERS OF

THE PUBLIC TO DISCUSS THE DEVELOPMENT OF GUIDELINES

FOR VOLUNTARY INDUSTRY INITIATIVES

By a staff requirements memorandum (SRM) dated May 27, 1999, the Commission approved the use of voluntary industry initiatives (VIIs) as an appropriate substitute for NRC regulatory action, where the action to be taken is needed to meet existing requirements or for cases where a substantial increase in overall protection can be achieved with costs of implementation justifying the increased protection. The SRM was issued in response to SECY-99-063, "The Use by Industry of Voluntary Initiatives in the Regulatory Process," dated March 2, 1999. An initial public meeting on this issue with interested stakeholders was held in Chicago, IL, on September 1, 1998.

On September 8, 1999, an internal NRC meeting was held to specifically determine guidelines to allow the drafting of an initial regulatory framework that supports the implementation of VIIs. A summary of this meeting, dated October 25, 1999, is publicly available.

On October 27, 1999, a second stakeholders meeting was held in Rosemont, IL, to obtain input from the industry, the Nuclear Energy Institute (NEI) and the public for the development of a regulatory framework to support the implementation of VIIs. The emphasis of the meeting was focused on nine areas, as specified in SECY-99-063: definition and initiation of voluntary industry initiatives, identification of staff and industry roles, tracking of licensee commitments, planning and resource allocation, fee management, developing inspection and monitoring guidelines, public participation, developing enforcement procedures, and schedule for finalizing guidelines/process.

On December 21, 1999, a third stakeholders meeting was held at the NRC's headquarters in Rockville, MD, to further explore the concept of VIIs. A copy of the transcript of this meeting is available in ADAMS under accession number ML003676383. A list of the attendees of the meeting is provided as Attachment 1.


