SUBJECT: RECIPROCITY FILING AND NOTICE OF VIOLATION

Dear Mr. Moscarello:

This refers to our review of your facsimile NRC Form 241 submitted on February 3, 2000, concerning your activities in Indiana and Wisconsin (non-Agreement States). The purpose of the review was to determine whether activities authorized by the license were conducted safely and in accordance with NRC requirements. At the conclusion of the review, the findings were discussed with you.

We are concerned about one violation of NRC requirements that was identified. The violation involves a failure to submit NRC Form 214 at least 3 days prior to initiating licensed activities within NRC's jurisdiction. The violation is cited in the enclosed Notice of Violation (Notice).

During conversations with you on February 3 and 7, 2000, members of my staff discussed the deficiencies in your request to work in non-Agreement States under reciprocity. I understand that you worked in Wisconsin and Indiana on January 18 and 24, 2000, respectively, however you indicated that you forgot to submit your reciprocity request. During your monthly program review, you indicated that you recognized that the Form 241s for the work performed in January 2000 had not been sent to NRC. When you identified the error you submitted the January forms along with a listing of the remaining year's work. On February 3, 2000, we received by fax, four NRC-241 forms (three of these forms listed the work you performed in Indiana and Wisconsin) along with your Illinois byproduct materials license and your fee payment. These documents correct the violation described in the Notice. Therefore, no reply to this violation is required and we have no further questions regarding this matter.
