
Gentlemen:

This letter provides information in accordance with 10 CFR 50.54(p)(2) concerning changes at Wolf Creek Generating Station (WCGS) affecting the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan. Attachment I provides a description of these changes and a justification for the changes. Attachment II identifies the commitments resulting from this correspondence.

Changes identified in Attachment I will be incorporated into the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan by August 31, 2000. These changes result from changes in personnel titles in the Wolf Creek Nuclear Operating Corporation organization and do not reduce the effectiveness of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan.

**Changes Affecting the Wolf Creek Generating Station (WCGS) Physical Security Plan,  
Safeguard Contingency Plan, and Security Training and Qualification Plan**

**Reasons and Justifications**

**Change 1**

Pages Affected: Throughout the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan.

Change: The title of Shift Supervisor is changed to Shift Manager.

Reason for Change: This title change was made during the implementation of Improved Technical Specifications (License Amendment No. 123). The WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan are being changed to incorporate this title change.

Justification: The title of Shift Supervisor has changed to Shift Manager; however, no responsibilities have changed. This title change has no effect on the implementation of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan. Therefore, this title change does not reduce the effectiveness of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan.

**Change 2**

Pages Affected: Throughout the WCGS Physical Security Plan, the Safeguards Contingency Plan, and the Security Training and Qualification Plan.

Change: The title of the Chief Operating Officer is changed to Vice President Operations Support.

Reason for Change: Wolf Creek Nuclear Operating Corporation has made organizational changes at the executive level.

Justification: All responsibilities are being maintained. The Vice President Operations Support will be responsible for all Security activities that were previously the responsibility of the Chief Operating Officer, with the exception that the Vice President Plant Operations & Plant Manager is responsible for operating the plant in a safe and secure manner. This title change has no effect on the implementation of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan. Therefore, this title change does not reduce the effectiveness of the WCGS Physical Security Plan, the Safeguards Contingency Plan, or the Security Training and Qualification Plan.
