POINT BEACH NUCLEAR PLANT, UNITS 1 AND 2

On November 24, 1999, Wisconsin Electric Power Company, licensee for the Point Beach Nuclear Plant, submitted an application requesting an order consenting to the transfer of operating authority for Point Beach Nuclear Plant from Wisconsin Electric Power Company to a newly formed operating company called Nuclear Management Company, LLC. Our application also requested conforming amendments to Operating Licenses Nos. DPR 24 and DPR 27 to include Nuclear Management Company, LLC as a licensee thereunder, and to designate Nuclear Management Company, LLC as the licensee authorized to use and operate Point Beach Nuclear Plant. This letter provides additional information that supplements our application request.

Wisconsin Electric's November 24, 1999, application identified the name and address of the successor licensee and the address of the principal officers of Nuclear Management Company, LLC as follows:
