OF JACK GUTTMAN**


Pursuant to 10 C.F.R. § 2.720(h)(2) and by agreement of the State of Utah and the NRC Staff, the State hereby gives notice that on March 10, 2000, its counsel will take the deposition upon oral examination of Jack Guttman, regarding Utah Contention H. The scope of the deposition will include the Staff's safety review of the thermal analyses of the PFS storage cask and the HI-STORM 100 cask system. The deponent is hereby instructed to produce at that time all documents upon which he has relied or intends to rely with respect to Utah Contention H and which have not previously been produced to the State by Private Fuel Storage, L.L.C.

The deposition will commence at 9 a.m. in the offices of Harmon, Curran, Spielberg, and Eisenberg. The deposition testimony will be taken before a duly authorized court reporter under oath and will be transcribed.
