MEMORANDUM AND ORDER
(Schedule for Prehearing Conference)

Previously, the Board had calendared a telephone prehearing conference for Tuesday, February 22, 2000, to discuss the scheduled March 14-15, 2000 hearing on contention Security-C, Local Law Enforcement. On Tuesday of this week, the Board received telephone notice from counsel for intervenor State of Utah (State) that the State had mailed a letter to the Board and the parties indicating it did not intend to make an appearance at the March 14, 2000 hearing. As of the issuance of this order, the Board has not received that correspondence. It has, however, received a letter from the NRC staff that (1) quotes a portion of an e-mail from counsel for the State that contains a similar representation about the State's participation; and (2) requests that the already scheduled Tuesday prehearing

conference be devoted to the subject of the status of the March 14-15, 2000 hearing. A similar suggestion was made yesterday by counsel for applicant Private Fuel Storage, L.L.C., (PFS) in a brief telephone call to the Board Chairman.

Under the circumstances, the Board believes it would be prudent to hold a telephone conference with counsel for the parties involved in litigating contention Security-C to obtain a clearer understanding of the status of March 2000 hearing and the potential application, if any, of 10 C.F.R. § 2.707 regarding party defaults.

Accordingly, the Board will conduct the previously scheduled telephone prehearing conference with the parties to the litigation on contention Security-C -- PFS, the State, and the staff -- on Tuesday, February 22, 2000, beginning at 11:30 a.m. EST (9:30 a.m. MST) (please note the time change). The Board will be contacting these parties to provide dial-in instructions. Any other party to the

proceeding that wishes to participate should contact the Board Chairman by 4:30 p.m. EST on Friday, February 18, 2000.


