Westinghouse Proprietary Information**

This letter provides a copy of the revised Westinghouse Electric Corporation report "Low Temperature Overpressure Protection System Setpoint Review for Beaver Valley Unit 2 15 EFPY Heatup and Cooldown Curves." The proprietary Westinghouse report is required to support License Amendment Request (LAR) 127 submitted by letter L-99-080, dated June 17, 1999, and currently under NRC review. LAR 127 proposed modifications to the heatup, cooldown and overpressure protection curves in the technical specifications for Unit 2. As this letter provides the latest revision of the Westinghouse report, it is requested that the previous versions of this report (both proprietary and non proprietary) originally submitted with LAR 127 be withdrawn from the docket and NRC review.

The revised Westinghouse report is provided at the request of the NRC. The revision is necessary because proprietary information in the Westinghouse report originally supplied with that LAR was not correctly identified. In order to appropriately identify the proprietary information contained within the report, Westinghouse has issued a revision to the report. The revised proprietary (Class 2C) and non proprietary (Class 3) versions of this report with the associated Proprietary Information Notice, Copyright Notice, and a Westinghouse application for withholding proprietary information are contained in Attachment A. The revision of this report also contains some minor clarifications, additional descriptive material and editorial changes (marked by revision bars) that do not affect the technical conclusions of the report. The changes to the report are summarized in Attachment B.


As the Class 2C version of the Westinghouse report contains information proprietary to Westinghouse, it is supported by an affidavit signed by Westinghouse, the owner of the information. This affidavit sets forth the basis on which the information may be withheld

from public disclosure by the Commission and addresses with specificity the considerations listed in paragraph (b) (4) of section 2.790 of the Commission's regulations. Accordingly, it is respectfully requested that the information which is proprietary to Westinghouse be withheld from public disclosure in accordance with 10 CFR Section 2.790 of the Commission's regulations.



## **PROPRIETARY INFORMATION NOTICE**
