The FCSS Licensing and International Safeguards Branch (LIB) requests technical assistance in reviewing the following project:

Project: To determine the adequacy of Fansteel's decommissioning funding plan revision for construction of a disposal cell (containment cell) and future release for restricted use. The relevant regulation is 10 CFR 20.1403(c). This submittal is a response to NRC interoffice memorandum dated June 22, 1999, and letter addressed to Fansteel dated August 18, 1999, regarding updates to Fansteel's decommissioning cost estimate.

Requested Action: To review Fansteel's response to the decommissioning funding plan revision dated January 27, 2000. Send a written response to Fansteel asking for either additional information or an acceptance letter confirming that Fansteel's has provided sufficient information containing acceptable financial assurance mechanisms, as described in 10 CFR 20.1403(c), for approval release under restricted use. Any deficiencies found should be itemized.
