Dear Mr. Welihozkiy,

This is in reference to your letter dated February 9, 2000, the Government of the Republic of Korea confirms the following particulars on the international transfer of ten fission chambers, containing high enriched uranium for use in Younggwang Units 1 and 2 by the Korea Electric Power Corporation(KEPCO). (export license No. XSNM3136);

- (a) The transfer of above material will be subject to all the terms and conditions of the Agreement for Cooperation Concerning the Civil Uses of Atomic Energy between the Government of the Republic of Korea and the Government of the United States, as amended, which enter into force on March 19, 1973;
- (b) The Korea Electric Power Corporation(KEPCO), the ultimate consignee, is authorized by the Government of the Republic of Korea to receive and possess the material.

In addition, I'd like to inform you that Nuclear Policy and Safeguards Division of Ministry of Science and Technology has been responsible for the nuclear control and non-proliferation since June 1, 1999.


