DOCKETS 50-266 AND 50-301 DYNAMIC EFFECTS DESIGN BASIS REVIEW REQUEST SUPPLEMENTAL INFORMATION POINT BEACH NUCLEAR PLANT, UNITS 1 AND 2

By letter dated December 2, 1999 (NPL-99-0705), Wisconsin Electric, licensee for Point Beach Nuclear Plant, Units 1 and 2, requested approval, per the requirements of GDC 4, to eliminate from consideration within the design basis the dynamic effects of certain piping system breaks.
