The following conditions apply:

(1) Individual pieces of graphite may not weight more than 400.0 kilograms; (2) Individual shipments may not exceed 18,000 kilograms; and (3) Re-exports to ASEAN countries i.e., Brunei, Indonesia, Malaysia, Philippines and Thailand, permitted under Singapore IDVC, be limited to (a) articles manufactured for non-nuclear end uses, or (b) general license quantities if bulk block or rod form.

All other conditions remain unchanged.
