On February 10, 2000, the Nuclear Regulatory Commission issued Amendment No. 94 to Facility Operating License No. NPF-63 for the Shearon Harris Nuclear Power Plant (HNP), Unit No. 1, in response to your request dated August 4, 1999, as supplemented on December 3, 1999, and January 11, 2000. This amendment revised HNP Technical Specification 6.9.1.6.2 to incorporate analytical methodology references which are used to determine core operating limits.

In your August 4, 1999, submittal you requested that "the proposed amendment be issued such that implementation will occur prior to core reload associated with Refueling Outage 9, currently scheduled to commence in April 2000." Contrary to your request, Amendment No. 94 stated that "This license amendment is effective as of the date of issuance and shall be implemented within 60 days of issuance."

Paragraph 3 of the license amendment has been revised to state that "This license amendment is effective as of its date of issuance and shall be implemented prior to core reload associated with Refueling Outage 9." A corrected license amendment page is enclosed.
