C - LICENSE SPECIFICATIONS

1. Material License Limitation:

This license authorizes Goodyear Aerospace Corporation, at its Akron, Ohio Facilities, to receive title to, own, acquire, deliver, receive, possess, use and transfer normal source materials and special nuclear material in the form of uranium compounds (chiefly in the form of Uranium Hexafluoride (UF₆) as follows:

UF ₆ Source Materials (Normal Uranium)	150# max.
Uranium-235 (up to 93.5% enrichment)	349 grams

The foregoing quantity is the maximum that will be possessed under this license at any one time.

At its Akron, Ohio Facility the licensee may perform the following activities:

- Receive, store and transfer normal source and special nuclear material.
- Utilize normal source and special nuclear material in Research and Development of uranium enrichment equipment.
- Collect and transfer waste and scrap containing normal source and special nuclear materials and uranium compounds generated in licensee's facilities.

3. Organization:
