Dear Mr. Weber:

The United States Nuclear Regulatory Commission (NRC) will be sponsoring visitors to observe the planned Operational Safeguards Response Evaluation (OSRE) at the Davis-Besse Nuclear Power Station starting March 6, 2000. The Davis-Besse organization wishes to welcome and accommodate the domestic and foreign visitors to the station during the evaluation. There is a responsibility to control the exposure of the visitors to safeguards information. For that reason, Davis-Besse will be requiring all OSRE visitors and observers to attend and satisfactorily complete an orientation training class concerning safeguards information.

This one-hour class will fulfill the Davis-Besse Nuclear Power Station's procedural requirements for access to safeguards information and will address responsibilities and accountabilities, including unauthorized disclosure of safeguards information. The training class will cover the roles and responsibilities of individuals that have access to safeguards information and is approximately the same training class that is provided to on-site licensee personnel prior to their having access to safeguards information. The proper control and disclosure of safeguards information is extremely important and required to protect the basis for the Davis-Besse security program.
