This Modification No. 7 to Contract No. NRC-28-97-206 corrects the expiration date of the contract. The correct expiration date is "7/6/00" and not "6/6/00". Accordingly, Section F.2 DURATION OF CONTRACT PERIOD is revised to read as follows:
