SUBJECT: SUMMARY OF NOVEMBER 22, 1999, MEETING WITH BGE REGARDING THE FORM AND CONTENT OF THE FINAL SAFETY ANALYSIS REPORT (FSAR) SUPPLEMENT, APPENDIX E OF THE FINAL SAFETY EVALUATION REPORT (FSER), AND THE RENEWED LICENSE FOR CCNPP

By letter dated October 25, 1999, the staff forwarded a model of a renewed license to BGE to illustrate how a list of minimum requirements, as listed in the FSAR supplement and Appendix E of the FSER, could be incorporated into a license condition. The FSAR supplement, a list of the applicant programs and activities that the staff will rely on to conclude that aging effects will be adequately managed for the period of extended operation, will be captured in the FSER as Appendix E. These minimum requirements would be captured as a license condition to ensure the requirements would be subject to regulatory control. By letter dated November 12, 1999, BGE submitted the FSAR supplement. Following this submittal, the staff held a public meeting with BGE on November 22, 1999, at Rockville, Maryland, to discuss the form and content of the FSAR supplement, Appendix E, and the renewed license. The purpose of the meeting was to reach agreement regarding how the regulatory commitments, as listed in the FSAR supplement and Appendix E of the SER, would be captured in the license. The enclosure to this meeting summary provides a list of the meeting attendees.

The NRC opened the meeting stating its position that the proposed renewed license would include 2 license conditions related to license renewal. The first license condition would require that the licensee update the FSAR, pursuant to 10 CFR Part 50.71(e), to include the FSAR supplement submitted pursuant to 10 CFR Part 54.21(d), as amended, and supplemented by the program descriptions in Appendix E to the FSER; and that until the FSAR update is complete, the licensee may make changes to the programs described in Appendix E without prior Commission approval, provided that the licensee evaluates each such change according to the criteria set forth in 10 CFR Part 50.59. The second license condition would require that future actions listed in Appendix E to the FSER be included in the FSAR, and that the actions shall be completed by the date specified in the FSER. If there is no schedule specified in Appendix E or the FSAR for a particular action, the licensee would complete the action by the end of the current license term. The schedule to complete an action may be delayed if the licensee submits a license amendment and receives Commission approval.

BGE proposed that the FSAR supplement and Appendix E be modified to change the dates of future actions to the end of the current term. The staff will review the current date commitments to determine if any were critical to the 10 CFR 54.29 finding. Date commitments that are not critical to the staff's findings can be changed to the end of the current term.
