The purpose of this modification is to obligate incremental funds in the amount of \$313,000.00 which thereby increases the obligated amount of this contract from \$1,275,938.00 to \$1,588,938.00.

Accordingly, the following changes are hereby made:

1. Under Subsection B.3 - CONSIDERATION AND OBLIGATION-COST PLUS FIXED FEE (JUN 1988) ALTERNATE I (JUN 1991), BASE PERIOD (Years 1 through 3) is hereby deleted in its entirety and substituted with the following in lieu thereof:

"BASE PERIOD (Years 1 through 3)

- (a) The total estimated cost to the Government for full performance of this contract is \$1,778,684.00, of which the sum of \$1,678,003.43 represents the estimated reimbursable costs, and of which \$100,680.57 represents the fixed fee.
- (b) There shall be no adjustment in the amount of the Contractor's fixed fee by reason of differences between any estimate of cost for performance of the work under this contract and the actual cost for performance of that work.
- (c) The amount currently obligated by the Government with respect to this contract is \$1,588,938.00 of which the sum of \$1,493,601.72 represents the estimated reimbursable costs, and of which \$95,336.28 represents the fixed fee.
- (d) It is estimated that the amount currently allotted will cover performance through 11/30/00."

All other terms and conditions of this contract inclusive of the ceiling amount of \$1,778,684.00, remain unchanged.
