**APPLICANT'S OPPOSITION TO STATE OF UTAH'S REQUEST TO BRIEF
THE LICENSING BOARD'S CERTIFIED QUESTION TO THE COMMISSION**

On March 17, 2000, the State of Utah asked the Commission for the opportunity to brief the question which the Atomic Safety and Licensing Board ("Licensing Board") referred to it in Private Fuel Storage, L.L.C. (Independent Spent Fuel Storage Installation), LBP-00-6, 51 NRC ___, slip op. at 70-72 (2000).¹ Pursuant to 10 C.F.R. § 2.730(c), Applicant Private Fuel Storage, L.L.C. ("PFS") files this answer opposing the request.

PFS respectfully submits that there is no need for the parties to brief the Commission on the referred question, nor indeed the need for the Commission to review it. There is already a fully-developed record. The parties have filed a substantial volume of pleadings concerning the referred question with the Licensing Board.² The Board has

carefully evaluated these arguments. See Private Fuel Storage, LBP-00-6, 51 NRC at __, slip op. at 11-19; Private Fuel Storage, L.L.C. (Independent Spent Fuel Storage Installation), LBP-00-7, 51 NRC __, slip op. at 2-8 (2000). PFS believes that further pleadings at this point would be both unnecessary and redundant. Indeed, the State's last pleading on the referred question merely incorporated by reference large portions of earlier pleadings related to the same issue.³


The Licensing Board has written a clear and sound ruling on the application of the Commission's decision in Louisiana Energy Services, L.P. (Claiborne Enrichment Center), CLI-97-15, 46 NRC 294 (1997) to the financial assurance requirements of 10 C.F.R. Part 72. While the State asserts that the referred question forms the heart of its concern regarding PFS's financial qualifications, the same can be said of any other issue disposed of on summary disposition. The Licensing Board carefully considered the question and correctly applied the Commission's Claiborne decision in disposing of the issues in the State's contention. Thus, no Commission action is needed at this time.


