Revision 11

Re-submittal of Transmittal Letter

The transmittal letter for Revision 11 to the Nuclear Security and Contingency Plan dated November 15, 1999 did not request Revision 11 to be withheld from public disclosure in accordance with 10 CFR 2.790(d)(1). This revised transmittal letter corrects this oversight and supersedes the November 15, 1999 transmittal letter.

Pursuant to 10 CFR 50.4(b)(4), enclosed are four copies of Revision 11 to the Duke Power Company Nuclear Security and Contingency Plan. The effective date of Revision 11 is November 16, 1999. The changes reflected in Revision 11 are being submitted pursuant to 10 CFR 50.54(p)(2).

A Synopsis of Changes is included to facilitate review. Details on the implementation of each change are documented and available for inspection. Revision 11 includes a statement that the Duke Power Company Nuclear Security and Contingency Plan is applicable to the McGuire Nuclear Station Independent Spent Fuel Storage Installation (ISFSI) which is located within the McGuire site protected area.

The Nuclear Security Training and Qualification Plan will not be revised to include a similar statement since the Nuclear Security and Contingency Plan requires station security personnel to be trained as outlined in the Nuclear Security Training and Qualification Plan. These changes do not decrease the safeguards effectiveness of the Nuclear Security and Contingency Plan.

Revision 11 does not contain Safeguards Information and is not subject to 10 CFR 73.21 requirement restrictions. However, Revision 11 does contain licensee physical protection information within the context of 10 CFR 2.790(d)(1) and Duke Power Company requests that it be withheld from public disclosure.
