Dear Mr. Templeton:

This refers to your letter dated February 28, 2000, responding to a violation of the deliberate misconduct rule. The violation occurred while you were providing health physics (HP) support during steam generator nozzle dam installation on April 16, 1999. We identified this violation to you by letter dated January 31, 2000. We conclude that your February 28 reply was responsive to our concerns, and we consider the matter closed.

In accordance with 10 CFR 2.790 of the NRC's "Rules of Practice," a copy of this letter with your home address redacted and your February 28 letter will be placed in the Public Document Room (PDR). Consistent with our statements in the January 31, 2000, letter, other correspondence related to this enforcement action have been placed in the PDR.
