In each of the license transfer proceedings referenced above, AmerGen Energy Company LLC submitted supplemental funding agreements under which PECO Energy Company and British Energy, plc have agreed to provide AmerGen with additional funding of up to \$110 million to provide further assurance that AmerGen will have sufficient funds available to meet the expenses associated with the ownership and operation of its nuclear power plants.

The purpose of this letter is to notify the Commission that PECO Energy Company and British Energy, plc have recently agreed to increase this funding commitment to AmerGen from \$110 million to \$200 million.






