NRC ADVISORY COMMITTEE ON REACTOR SAFEGUARDS TO MEET IN ROCKVILLE, MD, OCTOBER 6-8

The Nuclear Regulatory Commission's Advisory Committee on Reactor Safeguards has scheduled a technical meeting October 6-8 in Rockville, Maryland.

The meeting, which is open to the public, will be held in Conference Room T2B3, 11545 Rockville Pike.

Although meetings of the ACRS are open to the public, they are not part of the NRC's public hearing process. The ACRS, an advisory group to the Commission, conducts independent highly technical reviews of safety considerations related to nuclear facilities. While members of the public may attend the meeting, the committee will consider only oral or written statements limited to specific matters set forth in a notice of Meeting published in the Federal Register on September 26.

On Thursday, October 6, from 8:30 a.m. to 8:45 a.m., the ACRS chairman will make opening remarks.

From 8:45 a.m. to 10:45 a.m., the committee will meet with representatives of the NRC staff to discuss NRC test programs in support of certification for the Westinghouse AP600 and General Electric Simplified Boiling Water Reactor designs.

From 11:00 a.m. to 12:30 p.m., the committee will meet with representatives of the NRC staff to discuss a proposed revision 2 to Regulatory Guide 1.82, "Water Sources for Long-Term Recirculation Cooling Following a Loss-Of-Coolant Accident."

From 1:30 p.m. to 2:30 p.m., the committee will meet with representatives of the NRC staff to discuss reactor vessel structural integrity.

From 2:30 p.m. to 5:00 p.m., the committee will meet with the NRC's Director of the Office for Analysis and Evaluation of

Operational Data to discuss items of mutual interest, including the NRC technical training program.
