SUBJECT: INDIAN POINT NUCLEAR GENERATING UNIT NO. 2 - REVISED TIME LINE FOR NRC REVIEW AND INSPECTION ACTIVITIES (TAC NO. MA8219)

Dear Mr. Blind:

This letter updates our March 29, 2000, letter that provided time lines for various NRC activities. The updates primarily stem from changes to your projected dates for necessary submittals to the NRC.

On April 11, 2000, your staff informed Jefferey Harold, the Project Manager for Indian Point Nuclear Generating Unit No. 2 (IP2) that you would be delaying your response until April 26, 2000, to our March 14, and 24, 2000, requests for additional information (RAI) and your operational assessment. We have revised the time line we sent on March 29, 2000, to reflect this change. In addition, other updates have been made to reflect the current status. The revised time line is enclosed.

As we stated in our March 24, 2000, RAI, we will require adequate time to complete our steam generator condition review. At this time, we estimate 3 weeks, but that assumes the submitted information is of acceptable quality. Therefore, our revised estimated completion date for our safety evaluation is May 17, 2000.

As stated in our March 29, 2000, letter, this list is not all inclusive but addresses issues at a summary level that we are working on with respect to IP2. The schedules may change but represent our best estimate and will depend upon the timeliness and quality of submitted information. Furthermore, we recognize that since you reported steam generator inspection results as C-3 (Technical Specification 4.13, Table 4.13-1), NRC must approve restart. That item is shown in the enclosed table as item 6 with dates to be determined (TBD).
