In accordance with 10CFR50.54(p)(2), Entergy Nuclear Generation Company (Entergy) is submitting Issue 2, Revision 15 of the Pilgrim Station Security Plan, Revision 7 of the Security Contingency Plan, and Revision 11 of the Security Force Training and Qualification Plan.

Changes to the above documents were evaluated in accordance with the guidance provided in Generic Letter #95-08, "Process for Changes to Security Plans without Prior NRC Approval." A synopsis of changes for each document is attached. Changes were made pursuant to 10CFR50.54(p)(2). Also, the changes satisfactorily met the screening criteria of Attachment #1 to Generic Letter #95-08; therefore, these changes were evaluated not to decrease the effectiveness of the Security Program at Pilgrim Station and therefore prior NRC approval was not required prior to implementation.

The Security Plan and Security Contingency Plan contain "**Safeguards Information**" and require protection against unauthorized disclosure in accordance with 10CFR73.21. The Security Force Training and Qualification Plan contains "**Proprietary Information**" regarding the Pilgrim Security Program and therefore is exempt from public disclosure in accordance with 10CFR2.790(d).
