Is the RI-ISI program being developed for both Units?

TXU Response:

Yes - The RI-ISI program is being developed for both Unit 1 and

Unit 2.

When will the RI-ISI submittal be made?

TXU Response:

The RI-ISI submittal is currently scheduled for December 2000. The RI-ISI program is being developed concurrently with South Texas Project, Callaway, Wolf Creek and Diablo Canyon under

a Strategic Teaming and Resource Sharing (STARS)

arrangement.

Requested information:

When will the Unit 1 RI-ISI program be implemented?

TXU Response:

The Unit 1 RI-ISI program will be implemented upon NRC approval. Both Units 1 and 2 will stay on the same Code of

Record in the interim period between RI-ISI program

implementation and the time of the required Unit 2 Code update.

Unit 2 will be updated to the applicable Code Edition and

Addenda as required by 10CFR 50.55a.
