The following resolution was introduced by Councilman Heaney, seconded by Councilman Halsey, and duly adopted with the following recorded vote: All in favor:

WHEREAS, by Local Law No. 36 of 1999 adopted April 13, 1999, the Town Board of the Town of Southampton called for the closure of the Millstone Nuclear Power Station in Waterford, Connecticut and further requested New York State to file a petition with the United States Nuclear Regulatory Commission to provide for a fifty (50) mile plume exposure pathway emergency planning zone: and

WHEREAS, the voters of the Town of Southampton approved the adoption of Local Law No. 36 at a mandatory referendum held in November, 1999; now, therefore, be it

RESOLVED, the Town Board directs the Town Clerk to send a copy of Local Law No. 36 and the results of the mandatory referendum to Gov. George Pataki, Senator Kenneth Lavallo, Assemblyman Fred Thiele and Attorney General Elliot Spitzer and requests that the State of New York file a petition with the United States Nuclear Regulatory Commission requesting the establishment of a fifty (50) mile plume exposure pathway emergency planning zone to benefit Eastern Long Island.
