INSTRUCTIONS TO STUDENTS

ACCEPTANCE: This is to advise you that those individuals in Enclosure 1 have been accepted for participation in the training course (G-304) "Inspecting for Performance." This course is scheduled to be presented June 27-29, 2000, at the Nuclear Regulatory Commission's Region IV office located at 611 Ryan Plaza Drive, Arlington, Texas 76011-8064, Telephone (817) 860-8100.

COURSE: This course will be conducted beginning at 8:00 a.m. and end at 4:00 p.m. each day except for Thursday, June 8, 2000, when the class is scheduled to end at 12:00 noon.

LODGING AND TRAVEL: Enclosure 3 is a list of hotels in the Arlington area. You should plan to arrive on Monday, June 26, 2000, and depart on Thursday, June 29, 2000. Participants must make their own lodging arrangements. Individuals should request a State or government employee rate at the hotels.

Take Texas Highway 183 West approximately 1 mile to Texas Highway 360 South.

Take Highway 360 South approx. 5 miles to Lamar Drive West.

Take Lamar drive West to Harris Methodist Health Plan Building (second largest building in Arlington, sixteen stories). Just North of Interstate 30, between Collins and Cooper Streets, West of the Ballpark in Arlington, Six Flags Amusement Park, and Hurricane Harbor. NRC reception area is located on the fourth floor.
