Subject: Operating Reactor Licensing Action Estimates for the Davis-Besse Nuclear Power Station Through NRC Fiscal Year 2001

Ladies and Gentlemen:

The FirstEnergy Nuclear Operating Company (FENOC) is the operator and a licensee of the Davis-Besse Nuclear Power Station (DBNPS), Unit Number 1. Nuclear Regulatory Commission (NRC) Regulatory Issue Summary (RIS) 2000-04, "Operating Reactor Licensing Action Estimates," dated March 16, 2000, (DBNPS letter Log Number 5639) requested licensees to provide estimates of the number of future new licensing actions that will be submitted for NRC review during NRC fiscal years 2000 and 2001. These estimates are to be used by the NRC in planning adequate review resources.

By letter (Serial Number 2598) dated May 28, 1999, FENOC provided the NRC with the estimated number of future licensing actions during the NRC fiscal year 2000 ending September 30, 2000. In the attachment to this letter, FENOC is updating its estimated information for licensing actions through September 2001.

The FENOC is planning to submit several new significant licensing actions during this time period and requests that the NRC provide adequate review resources. These include: a license amendment application to re-rack the spent fuel pool, a risk-informed license amendment application to increase the allowed outage time to seven days for a Low Pressure Injection System and a Containment Spray System, a Babcock and Wilcox Owners Group (B&WOG) risk-informed Topical Report regarding the elimination of Large Break Loss-of-Coolant Accident (LBLOCA) loads from the Once-Through Steam Generator (OTSG) design, two license amendment applications regarding OTSG tube repair methods that will reference the aforementioned B&WOG Topical Report, and a B&WOG risk-informed Topical Report regarding the permanent removal of reactor

vessel missile shields. These are also listed in the attachment under the heading "Significant Licensing Actions".

The FENOC appreciates the opportunity to provide input to the NRC for resource planning purposes and to ensure the NRC is aware of significant licensing actions planned to be submitted for the DBNPS.
