On May 3, 2000, the licensee administered an NRC Reactor Operator written retake examination to an employee of your facility who had applied for a license to operate the H. B. Robinson Nuclear Plant. The NRC waived the operating examination. At the conclusion of the examination, the examiner discussed the examination questions and preliminary findings with those members of your staff identified in the enclosed report.

A copy of the written examination questions and answer key, as noted in Enclosure 2, was provided to the members of your training staff at the conclusion of the examination. The RO applicant who received the written examination passed the examination, representing a 100 percent pass rate.

SUMMARY OF FINDINGS

H.B. Robinson NRC Inspection Report 50-261/00-301

On May 3, 2000, the facility administered an NRC Reactor Operator initial written retake examination in accordance with the guidance of Examination Standards, (ES) NUREG-1021, Revision 8. This examination implemented the operator licensing requirements of 10 CFR §55.41. No significant issues were identified.

a. <u>Scope</u>

The NRC conducted a regular, announced operator licensing initial written retake examination on May 3, 2000.

b. Observations and Findings

The licensee developed the written examination in accordance with NUREG 1021, Revision 8. The NRC identified no significant examination material deficiencies. The RO applicant was granted a waiver by the NRC, from taking the operating examination since he previously passed this portion during the initial examination that was conducted in July, 1999. The facility administered and graded this written examination on May 3, 2000. The examination results were submitted to the NRC on May 10, 2000. The applicant passed the examination. The licensee submitted no post-examination comments.

The Chief Examiner presented the examination results on May 10, 2000 via telcon to Mr. J. Moyer, Vice President-Robinson Nuclear Plant and members of licensee management. The licensee acknowledged the examination results presented.
