PROGRAM MANAGEMENT INFORMATION: TECHNICAL CONFERENCING FORUM -AVAILABILITY OF DECOMMISSIONING STANDARD REVIEW PLAN (STP-00-043)

In All Agreement States letters SP-97-084, dated December 9, 1997, and SP-99-019, dated March 26, 1999, we described that the Nuclear Regulatory Commission's (NRC) primary means of distribution of pre-decisional and other documents of interest to Agreement States is the electronic subsystem that has been established for sole use by the Agreement States. This subsystem is under the Technical Conference Forum (TCF) of the NRC Home Page. The TCF subsystem can only be accessed by the Agreement States having an unique user name and password, which were last updated via All Agreement States letter SP-99-027.

We are announcing the availability of a Standard Review Plan (SRP) to be used by staff in evaluating information submitted by licensees to support the decommissioning of nuclear facilities. When completed in July 2000, the SRP will supersede Regulatory Guide 3.65 and 3.66, NUREG-1337, and applicable portions of the Inspection Manual Chapter (IMC) 2605 and the Nuclear Material Safety and Safeguards Decommissioning Handbook. Staff will update the IMC 2605 and the Decommissioning Handbook to reflect the SRP's procedures and criteria.

In August 1998, NRC published Draft Regulatory Guide DG-4006, "Demonstrating Compliance with the Radiological Criteria for License Termination." In late 1999 staff recognized that similar guidance was being presented in the SRP and decided to combine the guidance in DG-4006 with the guidance in the SRP. Staff does not plan to publish a final version of the guide, since the information in DG-4006 has been incorporated into the SRP. Comments submitted on DG-4006 will be addressed in the SRP.

Staff held workshops in December 1998, January, March, June, August 1999, and February 2000, on dose modeling, surveys, demonstrating the as low as reasonably accepted concept, the restricted use/alternate criteria, and to obtain stakeholder input. An additional workshop is being held on June 7 - 8, 2000, to discuss specific issues associated with dose modeling. Any comments or concerns submitted before June 8, 2000 will be addressed in this version of the SRP. Comments received after June 8 will be considered in the next revision.

Due to its pre-decisional nature, this document is exempt from public disclosure under NRC rules. We request that you limit distribution to your staff and not release the document publicly. If this document is released, please inform me or the individual listed below within 24 hours.
