Dear Mr. Patrick:

The purpose of this modification is to extend the period of performance through March 31, 2001, at no additional cost or obligation to the Government, due to delay in obtaining a Commission decision with regard to Part 41. This action is being taken as a result of a telephone conversation with Mr. Paul Maldonado, of CNWRA, on March 30, 2000, and the NRC Project Officer's RFP request of 3/30/00, in which both parties agreed to this no-cost extension. Accordingly, the task order is hereby modified as follows:

The first sentence of paragraph number two of the definitization letter is deleted in its entirety and the following is substituted in lieu thereof:

"Task Order number 1 shall be in effect from the date of the award through March 31, 2001 with a cost ceiling of \$396,253."

A summary of obligations under this contract, from date of the award through this modification, is given below:

This modification does not obligate any funds.
