

The Government hereby exercises Option Year Four to extend the term of the contract for one additional year, through May 12, 2001, in accordance with Subsections F.2 - DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) and I.5 - 52.217-9 OPTION TO EXTEND THE TERM OF THE CONTRACT (MAR 1989). Work during this period shall be performed as specified under subsection C.1 - STATEMENT OF WORK of this contract and in accordance with Subsection B.7 - PRICE SCHEDULE (OPTION YEAR FOUR) as reflected in Modification No. 10 of this contract.

As a result of the exercise of Option Year Four, the total estimated amount of this contract (ceiling) inclusive of the Base Year, Option Year One, Option Year Two, and Option Year Three is increased by \$321,609.75 (Option Year Four) from \$944,263.82 (Base Year, Option Year One, Option Year Two, and Option Year Three) to \$1,265,873.57.

As well, incremental funds of \$100,000.00 are hereby provided for the exercise of this option which thereby increases the obligated amount of this contract from \$747,022.51 to \$847,022.51.

Accordingly, the following changes are hereby made:

1. Under Subsection B.8 - CONSIDERATION AND OBLIGATION--DELIVERY ORDERS (JUN 1988), paragraphs (f) Total Obligations and (g) Total Combined Contract Ceiling are hereby deleted in their entirety and substituted with the following in lieu thereof:

"Total Obligations

- (f) The amount presently obligated with respect to this contract is \$847,022.51. The Contracting Officer may issue orders for work up to the amount presently obligated. This obligated amount may be unilaterally increased from time to time by the Contracting Officer by written modification to this contract. The obligated amount shall, at no time, exceed the contract ceiling as specified in paragraph (a) above. When and if the amount(s) paid and payable to the Contractor hereunder shall equal the obligated amount, the Contractor shall not be obligated to continue performance of the work unless and until the Contracting Officer shall increase the amount obligated with respect to this contract. Any work undertaken by the Contractor in excess of the obligated amount specified above is done so at the Contractor's sole risk.

Total Combined Contract Ceiling

- (g) The total combined estimated amount (ceiling) of this contract is \$1,265,873.57 which is inclusive of the Base Year and Option Years 1, 2, 3 and 4."

3. Subsection F.2 - DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988) is hereby deleted in its entirety and substituted with the following in lieu thereof:

"F.2 DURATION OF CONTRACT PERIOD (MAR 1987) ALTERNATE 4 (JUN 1988)

The ordering period for this contract shall commence on May 13, 1996 and will expire on May 12, 2001. Any orders issued during this period shall be completed within the time specified in the order, unless otherwise specified herein. (See 52.216-18 - Ordering.)"

All other terms and conditions of this contract remain unchanged.
