The WOG discussed the results of UT inspections that have occurred and explained that based on their results they would like to treat baffle bolt degradation as a potential aging management issue for license renewal. The WOG stated that they would submit a report with the results of the testing. The next issue discussed was materials reliability program (MRP) reactor internals issue task group/joint baffle barrel (JoBB) update. The WOG discussed the various strategies to be used for reactor internals/JoBB aging degradation program along with the tasks that need to be completed and a schedule for the various tasks. The last part of the meeting dealt with the WOG responses to requests for additional information related to WCAP-14577, "Reactor Vessel Internals."
