REQUEST FOR ADDITIONAL INFORMATION

1. Provide five year financial projections for each plant for which an indirect license transfer is requested. The information should be broken down in the following manner:
 - a) Revenue must be broken down to its identifiable components, capacity, availability and price, per year for each unit. Any other revenue can be categorized into its own major categories.
 - b) Expenses should be grouped according to major categories.
 - c) Draw down revenue after expenses to the net income before taxes and interest line.
 - d) Identify taxes and interest to give the net income after taxes and interest line.
2. Provide any documents that specify GENCO's assumption of PECO responsibilities and commitments to AmerGen.
3. Provide the capacity factors for each unit in 1999.
