Safety Light Corporation respectively requests an extension of the June 30, 2000 date for a schedule and plan for continuation of site remediation as outlined in condition 13 of radioactive material license 37-00030-02 to December 31, 2000.

The major reason for this request is the time overrun in the silo remediation project. The silo remediation was expected to be completed by the end of 1999. It is finally wrapping up on May 25, 2000. We are still waiting for results to come back from Barringer Laboratories to further characterize the waste for disposal. Safety Light Corporation needs to know the cost to dispose of the waste so that we can asses the funds that would be available for further decontamination of the site. We need to know that information before we can begin to put a plan together.

Also of concern, Safety Light Corporation is using a contractor other than the one that is doing the silo remediation. We felt it would not be in the best interest of the silo remediation to have a different contractor on the site at the same time since the contractor that was doing the silo remediation also bid on the project.
