Dear Mr. Frazee:

We have reviewed the final Washington regulations in the Washington Administrative Code (WAC) Chapter 246-246, WAC, Radiological Criteria for License Termination, [WAC 246-246-030(4)(b), WAC 246-246-050(1)(a), WAC 246-246-010(4), and WAC 246-246-030(3) and (5)(b)(iii)] which became effective April 16, 2000. The request was based on your March 20, 2000, e-mail. The final regulations are in response to one amendment identified in the enclosed Regulation Assessment Tracking System (RATS) Data Sheet. The changes were made to correct errors in editing, to correct translation from Federal to State language, and correct cross references, and no significant changes were made from the previous NRC review of these regulations dated December 14, 1999.

As a result of the NRC review, we have determined that the Washington regulations, as adopted, meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Washington regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
