Site: *Cabot Corporation or Stellite Division of Union Carbide Corporation or Kokomo Quarry or Cabot Carbon or Cabot Corp. High Tech Material Division or Haynes International or Washington Street Quarry*

Location: 400 or 410 South Washington Street, Kokomo, IN 46901

The site occupies about three and a half acres near downtown Kokomo. Prior to the implementation of a removal action at the site, it consisted of one acre of fill in the north section and two and a half acres of lake in the south section. The northwestern portion of the site was at or near street level. The east, south and west walls of the site were sheer and the quarry floor was located about 35 to 54 feet below street level.

Type of Activity: Beginning sometime in the 1950s, the site was used for the disposal of industrial waste.

Substances Involved: Low concentrations of volatile and semivolatile organic compounds were discovered in the soil at the site. Additionally, metal concentrations in the soil were found to be above background concentrations, and soil samples from the lake bottom and fill areas showed somewhat elevated levels of sulfides. Trans-1,2, dichloroethene was detected in water taken from a section of the site. Additionally, radioactive materials were discovered.


