INFORMED AMENDMENT APPLICATION ON STEAM GENERATOR TUBING FOR THE REMAINDER OF CYCLE 14 (TAC NOS. MA1951 AND MA8418)

Dear Mr. Anderson:

During a telephone conference between Entergy Operations, Inc. (Entergy) and the Nuclear Regulatory Commission (NRC) on May 31, 2000, NRC senior management discussed the progress you have been making in determining the acceptability of your steam generators to continue to operate beyond June 25, 2000. We have received your May 30, 2000, letter that provides additional information regarding the deterministic operational assessment of steam generator tubing for the remainder of Cycle 14. In that letter, you state that testing to date substantiates Entergy's previous position that the limiting flaw was capable of withstanding a differential pressure of greater than three times normal operating pressure (3 Δ P) with margin. Your letter also responds to the NRC's concerns set out by our letter dated May 2, 2000, and indicates that additional information will be provided when the testing is complete. We understand that this additional information will be provided by June 5 or 6, 2000.

Regarding the risk-informed amendment application, your staff recently provided the NRC with additional information on the tube flaw characterization, in response to the concerns raised in our letter dated May 12, 2000. However, at this time it's not clear whether it addresses our concerns. The NRC staff is currently reviewing this information and will be engaging your staff to discuss it.

The NRC intends to make findings on both the deterministic assessment and the risk-informed application as soon as possible. In that regard, it is imperative that you provide us with the additional information discussed above for the deterministic assessment as soon as possible, and continue to support the NRC's review of the risk-informed application. We will be reviewing all of the latest information in preparation for a meeting with you on June 8, 2000.

Please inform your NRC Project Manager, Mr. Thomas Alexion, should circumstances change.
