Dear Mr. Ortciger:

As requested, we have reviewed the proposed changes to regulations in 32 Ill. Adm. Code 330, "Licensing of Radioactive Material" and 32 Ill. Adm. Code 326, "Financial Assurance Requirements," sent to us in Kathy Allen's January 3 and 25, 2000 letters and March 31, 2000 facsimile. The proposed and final regulations are in response to the seven amendments identified in the enclosed Regulation Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent Nuclear Regulatory Commission (NRC) regulations in 10 CFR Parts 20, 30, 40, 61, 70 and 150. We also discussed our review of the regulations with Kathy Allen on March 31, 2000.

As a result of our review, we have no comments on the proposed and final regulations. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulations are adopted without significant change, they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in the STP Procedure SA-201, Review of State Regulations (November 10, 1998), please highlight the final changes and send one copy in a computer readable format, if possible.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Illinois regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
