Acting on your appeal, I have carefully reviewed the record in this case and have determined that the previously withheld information will continue to be withheld from public disclosure pursuant to Exemption 3 of the FOIA (5 U.S.C. 552(b)(3)) and 10 CFR 9.17(a)(3) of the Commission's regulations. Exemption 3 of the FOIA incorporates the disclosure prohibitions contained in other Federal statutes. The National Defense Authorization Act (41 U.S.C. Section 253(b), subsection (m)(1)), enacted in 1996, provides protection from public disclosure of the successful offeror's proposal if it is not incorporated in the final contract. Moreover, the National Defense Authorization Act does not permit Federal agencies' the discretion to release this information.
