Dear Dr. Volpe:

As requested, we have reviewed the proposed regulation revisions to Kentucky Administrative Regulations, 902 KAR 100, provided to us by letter dated February 23, 2000, and the draft definitions (902 KAR 100:010) provided to Mr. Woodruff on April 24, 2000. The proposed regulations are in response to the six amendments identified in the enclosed Regulations Assessment Tracking System (RATS) Data Sheet. The regulations were reviewed by comparison to the equivalent NRC regulations in 10 CFR Parts 19, 20, 30, 40, 61, 70, 71, and 150. Mr. Woodruff also discussed our review of the regulations with you on April 28, 2000 and his preliminary comments and a RATS data sheet were sent to you by e-mail on May 10, 2000.

As a result of our review and discussions with you and Ms. Vicki Jeffs of your staff, we have four comments concerning the draft definitions that have been identified in the enclosure. Please note that we have limited our review to regulations required for compatibility and/or health and safety. Under our current procedure, a finding that a State regulation meets the compatibility and health and safety categories of the equivalent NRC regulation may only be made based on a review of the final State regulation. However, we have determined that if your proposed regulations were adopted incorporating the comments and without other significant change, they would meet the compatibility and health and safety categories established in the Office of State and Tribal Programs (STP) Procedure SA-200.

We request that when the proposed regulations are adopted and published as final regulations, a copy of the "as published" regulations be provided to us for review. As requested in STP Procedure SA-201, *Review of State Regulations*, November 10, 1998, please highlight the final changes and send one copy in a computer readable format, if possible.

We have also summarized on the RATS Data Sheet our knowledge of the status of other Kentucky regulations. Please let us know if you note any inaccuracies or have any comments on the information contained in the RATS Data Sheet.
