## **AFFIDAVIT**

- 1. Affiant is personally familiar with the trade secrets and privileged information contained in the Response to the Telecon Request for Additional Information (RAI) being submitted in conjunction with the request for approval of the Maine Yankee Amendment to the NAC-UMS® Certificate of Compliance. Affiant requests that the Nuclear Regulatory Commission, pursuant to Chapter 10 of the Code of Federal Regulations, Part 2.790 (10 CFR 2.790) "Public Inspections, Exemptions, Request for Withholding," withhold the information contained in the Calculation Package provided as part of this submittal, hereafter referred to as the Proprietary Material, from public disclosure.
- 2. This information has been and is held in confidence by NAC International.
- 3. The information contained within the proprietary material is the result of design calculations and computer code development performed by NAC. This type of information is held in confidence based on the significant commercial investment of time and money expended in its development.
- 4. The proprietary material is transmitted to the Nuclear Regulatory Commission in confidence.
- 5. The information that is being claimed as trade secrets and privileged information has not been and is not available in public sources.

6. NAC has invested a considerable amount of time, engineering labor, and money in the development of the information. Public disclosure of this information would cause substantial harm to the competitive position of NAC.
