SUBJECT: MODIFICATION NO. 14 TO INTERAGENCY AGREEMENT NO.
NRC-09-93-233 ENTITLED, "NUCLEAR SAFETY ATTACHE POSITION
AT U.S. MISSION IN VIENNA"

Dear Mr. Simpson:

The purpose of this modification is (1) to provide funds of \$21,200 for overlap costs in August and September, 2000, to allow the current Nuclear Safety (NS) Attache in Vienna, whose appointment ends at the end of September 2000, to train the next Nuclear Safety Attache, and (2) to provide funds of \$10,000 for a Rental Finders Fee (approximately 3 months rent) which may be required to locate new housing for the next NS Attache.

The overlap costs include the following job codes and amounts:

Salary and Post Allowance, Job Code A0330, BOC 1100:	\$18,344
Benefits and Rent, Job Code L1445, BOC 1210:	\$12,856
TOTAL	\$31,200

Therefore, Article III for fiscal year 2000 of the subject Interagency Agreement is modified as follows:
