The purpose of this modification is to: (1) exercise Option Year One, thereby extending the period of performance for 12 months, (2) obligate FY 2000 funds in the amount of \$156,294.00, thereby increasing the firm fixed price amount of the contract from \$202,768.00 to \$359,062.00, and (3) ADD contract section B.14 to incorporate language regarding the duration of the contract. Accordingly, the contract is hereby modified as follows:

1. Subsection B.6, "CONSIDERATION AND OBLIGATION--FIRM FIXED PRICE (JUN 1988)," as a result of exercising Option Year One, funding in the amount of \$156,294.00 is obligated for the continuance of contractor performance. Therefore, the firm fixed price amount of this contract is increased by \$156,294.00 from \$202,768.00 to \$359,062.00.
2. Under Section B, a subsection is being added that was inadvertently omitted from the contract. Subsection B.14 entitled "Duration of Contract Period," is added to give the duration of the contract from inception of the contract through Option Year One. Therefore, B.14 is incorporated under the subject contract as follows:

"B.14 DURATION OF CONTRACT PERIOD (MAR 1987)
ALTERNATE 2 (MAR 1987)

This contract shall commence on 5/06/99 and will expire on 5/05/2001.
The term of this contract may be extended at the option of the Government for an additional three (3) years."

All other terms and conditions remain unchanged.
