

The purpose of this modification is to: 1) exercise the option year, thereby extending the period of performance and increasing the total estimated amount (ceiling) for performance of the subject contract from \$24,781 by \$10,999 to \$35,780. Accordingly, the following changes are hereby made:

1. Subsection B.3 - Consideration and Obligation -- Cost Reimbursement, is hereby deleted in its entirety and the following is substituted in lieu thereof the following:

"B.3 Consideration and Obligation - Time and Materials/Labor Hour

- a. The total estimated cost to the Government for performance under this contract for the basic contract and Option year 1 is \$35,780.
  - b. Option Year 1 is hereby exercised at a total estimated cost to the Government of \$10,999."
  - c. The amount obligated by the Government with respect to this contract is \$24,781.
  - d. It is estimated that the amount currently allotted will cover performance through March, 30, 2001.
2. Under Section F - Deliveries or Performance, Paragraph, F.2 - Duration of Contract Period is hereby deleted in its entirety and substituted in lieu thereof the following:

"F.2 Duration of Contract Period

The contract shall comment on August 25, 1999 and will expire on August 24, 2001.

This modification obligates \$4,000.

All other terms and conditions remain unchanged.
