The purpose of this modification is to increase the maximum ordering limitation by \$480,000 from \$2,288,366 to \$2,768,366. Accordingly, the following changes are hereby made:

1. Under Section B.3, Consideration and Obligation--Task Orders (AUG 1989), Alternate 1 (JUN 1991), paragraph (a) is deleted in its entirety and the following is substituted in lieu thereof:

"(a) The Maximum Ordering Limitation (MOL) for products and services ordered, delivered and accepted under this contract is \$2,768,366. The Contracting Officer may place orders with the contractor during the contract period provided the aggregate amount of such orders does not exceed the MOL."

2. Section B.4, Minimum and Maximum Quantities, is hereby deleted in its entirety and the following is substituted in lieu thereof:

The minimum quantity the Government will order the contractor shall furnish will be at least 20% of the mutually agreed upon ceiling amount of the resultant contract which is \$457,673.20. The maximum quantity the Government will order and the contractor shall furnish shall not exceed the mutually agreed upon ceiling amount of the resultant contract which is \$2,768,366.00."

All other terms and conditions of the contract remain the same.
