Subject: Request for Proposal - Task Order No. 22 entitled "Technical Assistance on the Revision of Guidance for Amending the Part 50 Decommissioning Trust," under Contract No. NRC-04-95-065

ICF, Inc. is requested to submit a technical and cost proposal in response to the attached Statement of Work for the subject task order. Please submit three (3) copies, an original and two (2) copies, of both the technical and cost proposal in response to this RFP. Your response should be received by the U.S. Nuclear Regulatory Commission at or before 5:00 PM on Friday, May 5, 2000.

Your proposal must consist of two parts. The first part is your technical approach, and, as a minimum, shall substantiate your understanding of the requirements of the proposed effort, note any anticipated problem areas or deviations from the Statement of Work, identify key personnel who will perform the work, include resumes of those personnel not already in the contract and identify any potential conflict of interest issues. The second part of your proposal is your cost estimate.

In addition, you are required to identify any current/former NRC employees who have been or will be involved, directly or indirectly, in developing the proposal, or in negotiating on behalf of your firm, or in managing, administering or performing any contracts, consultant agreement or subcontract resulting from this proposal (list name, title and date individual left NRC and provide a brief description of the individual's role under this proposal.) If there are no current/former NRC employees involved, a negative statement is required.

1.0 Background

In a February 9, 2000, staff requirements memorandum (SRM), the Commission approved the staff's request and endorsed the rulemaking plan for Decommissioning Trust Provisions submitted in SECY-00-0002 on December 30, 1999. Also, the Commission directed the staff to proceed with the rulemaking and a revision of the associated Regulatory Guide 1.159, "Assuring the Availability of Funds for Decommissioning Nuclear Reactors."

2.0 Objective

The objective of this task is for the contractor to assist the NRC staff by developing revised sample language for trust agreements and escrow accounts consistent with the terms and conditions within the proposed revised rule. This sample language is currently contained in Appendices B.1 and B.3 of Regulatory Guide 1.159. This product will also be similar to the trust fund and escrow account language contained in Draft Regulatory Guide DG-3014, "Standard Format and Content of Financial Assurance Mechanisms Required for Decommissioning Under 10 CFR Parts 30, 40, 70, and 72," which was issued in June 1999, and planned to be used by licensees of the NRC's Office of Nuclear Material Safety and Safeguards.

3.0 Special Qualifications Required

NRC anticipates the contractor shall need specific expertise in finance and law relating to decommissioning trusts and escrow agreements.

4.0 Work Requirements and Schedule

The contractor shall develop draft revisions to Appendices B.1 and B.3 of Regulatory Guide 1.159. Based upon the NRC's draft (in consultation with the contractor) amending of the Part 50 Decommissioning Trust Provisions and Escrow Agreements, the contractor shall produce a draft regulatory guide for NRC's review and comment. This draft will be due within 2.5 months from the NRC's issuance of this task order. NRC shall respond to the initial draft within 1 month of the draft's receipt. The contractor shall then provide a final draft within 2 weeks of the contractor's receipt of NRC's comments.

5.0 Level of Effort

The level of effort for this task is estimated to be 3.5 professional staff-weeks for a senior financial analyst and 3.5 professional staff-weeks for an attorney.

6.0 Period of Performance

The period of performance for this task order is from date of issuance through October 31, 2000.

7.0 Meetings and Travel

NRC expects to have 3 meetings with 2 contractor staff members at NRC Headquarters in Rockville, MD, involving only local travel.

8.0 NRC-Furnished Material

NRC staff will provide the contractor copies of: SECY-00-0002; the February 9, 2000, SRM; Draft Regulatory Guide DG-3014; NUREG-1337, Revision 2, "Standard Review Plan for the Review of Financial Assurance Mechanisms for Decommissioning Under 10 CFR Parts 30, 40, 70, and 72"; and specific provisions to be included in trust and escrow agreements.

9.0 Deliverables

The contractor shall provide both draft and final draft versions of the revision to Appendices B.1 and B.3 to Regulatory Guide 1.159 as specified in Section 4.0.
