SUBJECT: MAY 11, 2000 PUBLIC MEETING SUMMARY

The purpose of this public meeting was to afford an opportunity for NRC staff, industry, and interested members of the public to discuss potential revisions to 10 CFR 50.54(p). Attached is the attendance sheet completed by participants of this public meeting.

The NRC staff summarized the results of its review of the potential revisions to 10 CFR 50.54(p) to accommodate an industry request for immediate relief from certain physical security plan (PSP) commitments. The Nuclear Energy Institute (NEI) stated that industry would refocus these assets to the current performance based programs and Baseline Inspection Program. In order to facilitate these identified plan changes, industry submitted one request under the provisions of 10 CFR 50.90 for seven plan changes and one request for exemption from four regulatory requirements. The NRC staff stated that these requests will be reviewed with consideration to potential generic application of the basis of the safeguards evaluation to multiple licensee sites.

NEI asked that, if approved, these plan changes be applied to all licensees who meet the same conditions such that other licensees could make the same plan changes under the provisions of 10 CFR 50.54(p). NEI also stated that the term "decrease of effectiveness", as used in 10 CFR 50.54(p)(2), should be defined. Periodic updates of the NRC staff review for each of these 11 requested plan changes will be provided to NEI.
