Dear Mr. Charette:

Based on the information submitted in your letter dated February 17, 2000, requesting to change the name of the manufacturer/distributor, we have changed the registration certificates as shown in Enclosure. Specifically, we responded to your request with the following actions: (1) we replaced Theratronics' registration certificates (NR-687-D-101-S and NR-687-D-105-S) with inactive registration certificates (NR-8113-D-801-S and NR-8113-D-804-S); and (2) we issued new registration certificates to MDS Nordion (NR-0220-D-114-S and NR-0220-D-117-S). Copies of the new registration certificates are enclosed.

Please be advised that you must manufacture and distribute the product in accordance with the statements and representations contained in your application, with enclosures thereto, and the information set out in your registration certificate.
