Millstone Nuclear Power Station, Unit Nos. 1, 2, and 3 Supplement to Annual Radioactive Effluent Report

On April 28, 2000, Northeast Nuclear Energy Company (NNECO) transmitted the Annual Radioactive Effluent Report covering the period of January through December 1999.⁽¹⁾ In accordance with Sections 5.6.1c, 6.9.1.6, and 6.9.1.4 of the Millstone Unit Nos. 1, 2, and 3 Technical Specifications respectively, contained within the letter as Attachment 2 was the Radiological Effluent Monitoring and Offsite Dose Calculation Manual (REMODCM). However, a section of the manual was inadvertently omitted. The purpose of this letter is to transmit a complete REMODCM.

Included as Attachment 1 is the complete REMODCM for Millstone Nuclear Power Station. NNECO requests that the previous version be replaced with the version contained within.

There are no regulatory commitments contained within this letter.
